- I understand that the college will electronically post my 1098-T form (Tuition Statement) to my WebAdvisor account so I can download the form for tax purposes. If I need a paper copy I can contact Student Central at (315) 498-2000 to request a paper copy be sent to the address of record. The college will continue to maintain the 1098-T form on my WebAdvisor account indefinitely. I understand that I am responsible for providing the college with my valid social security number and any updated contact information via WebAdvisor or in person at Student Central. I understand that a computer with internet capabilities is necessary to access my 1098-T form. The duration of this consent shall continue indefinitely or until the college is notified in writing that the consent is withdrawn
