# **SECURITY GUARD TRAINING**

8 Hour Pre-Assignment Training Course for Security Guards (Tuition is \$75) – This is an 8 hour course required by New York State as the first step in obtaining a security guard registration card from the New York State Department of State. The course provides the student with a general overview of the duties and responsibilities of a security guard. Topics covered in this course include the role of the security guard, legal powers and limitations, emergency situations, communications and public relations, access control, and ethics and conduct. All students must attend 100% of the 8hr course, and pass an examination for successful completion of this course.
