**WHEREAS,** the College administration has developed and presented a base institutional operating budget request of \$67,969,476 and proposed grant funding of \$5,600,000 for 2025-26;

**NOW, THEREFORE BE IT RESOLVED,** that subject to the approval of the County Legislature, a base institutional operating budget, including grant activity, for the 2025-26 fiscal year in the total amount of \$73,569,476 with a sponsor contribution of up to \$10,072,000 be adopted and submitted to the Board of Trustees of the State University of New York for approval.

WHEREAS, the purpose and mission of the Onondaga Community College Association, Inc. (OCCA), is to establish, manage and promote educational, cultural, athletic, social, and supportive activities and programs for Onondaga Community College students in collaboration with Onondaga Community College (the College); and

WHEREAS, the OCCA has prepared its 2025-26 operating budget using a zero-based budget approach consistent with the College's budget model, and the OCCA Board of Directors exercised due diligence in reviewing the 2025-26 operating budget; and

WHEREAS, on May 7, 2025, the OCCA Finance and Audit Committee presented to the OCCA Board of Directors and recommended Board approval of a balanced budget in the amount of \$3,548,471 which includes a per semester student activity fee of \$65.00 for full-time students and \$40.00 for part-time students per semester; the one-time new student programming fee of \$34.00 per semester; and the Recreation and Wellness Fee for full-time students at \$125.00 and for part-time students at \$85.00 per semester, and

WHEREAS, the 2025-26 operating budget provides for and allocates resources in a manner that is consistent with the OCCA and College mission and goals, as well as the mission, goals and objectives of the affiliate entities; and

WHEREAS, the OCCA Board of Directors reviewed and approved its 2025-26 operating budget at its meeting on May 7, 2025; and

**WHEREAS**, the OCCA Board of Directors approved a student activity fee of \$65.00 for full-time students and \$40.00 for part-time students per semester; the one-time new student programming fee of \$34.00 per semester; and the Recreation and Wellness Fee for full-time students at \$125.00 and for part-time students at \$85.00 per semester;

**NOW, THEREFORE BE IT RESOLVED,** that the Onondaga Community College Board of Trustees approves the OCCA operating budget for the 2025-26 fiscal year.

## RESOLUTION TO AWARD THE STATE UNIVERSITY OF NEW YORK/ ONONDAGA COMMUNITY COLLEGE HONORARY ASSOCIATE OF ARTS DEGREE TO DR. IRVING & JUDGE AVA RAPHAEL

WHEREAS, the Honorary Associate of Arts Degree is the highest form of recognition offered by Onondaga Community College to persons of exceptional distinction; and

WHEREAS, the purpose of the honorary degree is to honor meritorious and outstanding service to the College, the State of New York, the United States, and/or to the community at large and to recognize persons whose lives serve as examples of the College's aspirations for its students; and

WHEREAS, Dr. Irving Raphael was the Director of Sports Medicine and Head Team Physician for Syracuse University and was a fixture at football, basketball and lacrosse games for 27 years. He also served as Head Team Physician at Cazenovia College and was an orthopedic consultant to the NCAA, NBA, NFL, and PGA. A graduate of Yale University School of Medicine, Dr. Raphael completed his orthopedic residency at Upstate Medical University, where he was a Clinical Assistant Professor of Orthopedics. He is a member of the American Academy of Orthopedic Surgeons, the American Orthopedic Society for Sports Medicine, the International Arthroscopy Association, and is board certified in orthopedic surgery; and

WHEREAS, Judge Ava Raphael was the Surrogate Court Judge for Onondaga County from January 2009 until her retirement in December 2017. She also served as acting Supreme Court Justice and as judicial hearing officer for the Fifth Judicial District of New York State. Judge Raphael began her law career as an Associate with Mackenzie Hughes LLP, where she concentrated in appellate practice and medical litigation. She earned a Bachelor of Science and a Master of Arts from Syracuse University and a J.D. Magna Cum Laude from Syracuse University College of Law; and

WHEREAS, the Raphael's have long-served Onondaga Community College philanthropically, as had Judge Raphael's father, Ephraim Shapero, before her. In recognition of their decades of support, the College's newest residence hall was named "Shapero Hall." The Lillian Slutzker Honors College at OCC, also developed through generous support from the Raphael's, provides opportunities for high achieving students and helps them to reach their transfer and workforce goals while relieving some of their financial burden. The Honors College allows students in the program to engage with course material in greater depth, with less of an emphasis on completing a designation and more on providing opportunities to all qualified students for growth and engagement in the classroom; and

WHEREAS, for their meritorious and outstanding service to Onondaga Community College, Onondaga County, and the greater Central New York Community, the Board Officers and President Warren Hilton, Ed.D., recommend that the Board of Trustees grant an Honorary Associate of Arts Degree to Dr. Irving and Judge Ava Raphael; and

WHEREAS, the Board of Trustees has the authority to award all honorary associate degrees in the name of the State University of New York;

## RESOLUTION TO AWARD THE STATE UNIVERSITY OF NEW YORK/ ONONDAGA COMMUNITY COLLEGE HONORARY ASSOCIATE OF ARTS DEGREE TO HEATHER DRAKE-BIANCHI

WHEREAS, the Honorary Associate of Arts Degree is the highest form of recognition offered by Onondaga Community College to persons of exceptional distinction; and

WHEREAS, the purpose of the honorary degree is to honor meritorious and outstanding service to the College, the State of New York, the United States, and/or to the community at large and to recognize persons whose lives serve as examples of the College's aspirations for its students; and

WHEREAS, Heather Drake-Bianchi has dedicated her professional life to the well-being of others and, in the process, contributed greatly to the success of one of Onondaga Community College's programs which helps fulfill a critical workforce need in the community. A graduate of West Genesee High School and SUNY Upstate Medical University, she is both the founder of and a critical care paramedic with CineMedic CNY, a company which provides medical services on movie sets. During the Covid pandemic, CineMedic CNY mastered the skills associated with being a clinical laboratory that specializes in logistics in austere environments. They created daily Covid testing protocols on movie sets which became the industry standard; and

WHEREAS, in 2021, Ms. Drake-Bianchi learned OCC had created Paramedic Degree and certificate programs in conjunction with SUNY Upstate Medical University. She responded to the critical need in the community for paramedics by gifting the OCC Foundation \$80,000 for the creation of a two-tiered student scholarship program; and

WHEREAS, doctor's offices and emergency rooms have become overwhelmed with people in need of medical treatment. The strain and stress on the system led Ms. Drake-Bianchi to open Drakos Urgent Care, a pediatric urgent care center in Clay in 2023. The response was so phenomenal, she opened a second facility in Cicero in 2024 which caters to both children and adults and is open until midnight seven days a week. A third location will open in Camillus at the end of 2025. The Central New York Business Journal named Drakos Urgent Care as one of the top places to work in 2024 for business with 15-50 employees – a number that is expected to grow with the opening of the third location; and

WHEREAS, for her meritorious and outstanding service to Onondaga Community College, Onondaga County, and the greater Central New York Community, the Board Officers and President Warren Hilton, Ed.D., recommend that the Board of Trustees grant an Honorary Associate of Arts Degree to Heather Drake-Bianchi; and

WHEREAS, the Board of Trustees has the authority to award all honorary associate degrees in the name of the State University of New York;

## RESOLUTION TO AWARD THE STATE UNIVERSITY OF NEW YORK/ ONONDAGA COMMUNITY COLLEGE HONORARY ASSOCIATE OF ARTS DEGREE TO MARY PORCARI BRADY POSTHUMOUSLY

WHEREAS, the Honorary Associate of Arts Degree is the highest form of recognition offered by Onondaga Community College to persons of exceptional distinction; and

WHEREAS, the purpose of the honorary degree is to honor meritorious and outstanding service to the College, the State of New York, the United States, and/or to the community at large and to recognize persons whose lives serve as examples of the College's aspirations for its students; and

WHEREAS, in 1969, Mary Davis Porcari lost the youngest of her five children, Mary Elizabeth, to a rare genetic disorder. Following this tragedy, Mary was determined to become a Registered Nurse like her mother before her. While raising her surviving children at home, she enrolled in the nursing program at Monroe Community College, studying nights, weekends and holidays to earn her RN in 1972. Mary went on to a career as a medical-surgical nurse, also volunteering at local non-profits when time allowed. Remarried, Mary Porcari Brady retired in 2000, passing unexpectedly in 2001. With their late Mom's lessons of service and committing to something larger than oneself in mind, in 2005 her four surviving children approached the Monroe Community College School of Nursing and asked them to identify an unmet need. In 2006, the Mary Porcari Brady (MPB) Fund was born. Jinny Porcari Keough, James A. Porcari III, John D. Porcari and Charles F. Porcari established the fund, which has since expanded to five other Upstate New York community college campuses, and has distributed over \$1 million helping hundreds of student nurses obtain their degrees; and

WHEREAS, the MPB Fund provides support for non-tuition expenses that might have forced students to withdraw from school. Expenses that are covered include childcare, emergency auto repairs, utility expenses, LPN-to-RN program and other mandated testing fees, and out-of-pocket costs for nursing student supply bags, uniforms, scrubs and shoes. At the outset of the COVID-19 epidemic, the MPB Fund provided emergency funds for PPE for use in both classroom and clinical settings; and

WHEREAS, created and maintained in concert with faculty at Monroe Community College, Onondaga Community College, Finger Lakes Community College, Cayuga Community College and Tompkins-Cortland Community College, and the Marine Corps Scholarship Foundation, the purpose of the MPB Fund – to provide students a temporary bridge in times of unexpected need – will continue to be its guiding light. All donations go directly to nursing students. The surviving children of the late Mary Porcari Brady cover all administrative overhead and ancillary costs; and

WHEREAS, for her meritorious and outstanding service to Onondaga Community College, Onondaga County, and the greater Central New York Community, the Board Officers and President Warren Hilton, Ed.D., recommend that the Board of Trustees grant an Honorary Associate of Arts Degree to Mary Porcari Brady posthumously; and

WHEREAS, the Board of Trustees has the authority to award all honorary associate degrees in the name of the State University of New York;

**NOW, THEREFORE BE IT RESOLVED,** that the Onondaga Community College Board of Trustees does hereby award the State University of New York/Onondaga Community College Honorary Associate of Arts Degree to Mary Porcari Brady posthumously at the Onondaga Community College Commencement on May 17, 2025.

Eventually Mr. Kent went into private practice, doing government affairs work; and

WHEREAS, Mr. Kent spent 13 years serving as the General Counsel for the Office of Addiction Services and Supports which led to an opportunity in 2020 at the highest level as General Counsel at the White House Office of National Drug Control Policy. Currently, Mr. Kent serves as President of Kent Strategic Advisors, helping agencies that provide addiction services the support and resources they need to be successful; and

**WHEREAS**, Mr. Kent's ties to OCC came full circle in 2018 when his oldest son, Sam, earned his Communications degree while serving as Manager on the National Champion Men's Lacrosse team; and

#### RESOLUTION TO APPROVE COLLEEN STEVENS AS THE RECIPIENT OF THE 2025 RALPH R. WHITNEY, JR., AWARD

WHEREAS, as part of the Onondaga Community College Board of Trustees Awards program, the Ralph R. Whitney, Jr., Award was established to honor a faculty member who embodies the College's mission of providing educational programs of high value in an environment that inspires academic excellence, and stimulates engagement in local and global communities; and

WHEREAS, Colleen Stevens began her career at Onondaga Community College in 2017 as a professor in Mathematics. She left that role due to enrollment declines and became Director of the Collegiate Science and Technology Entry Program (CSTEP), a position she held from 2021-2024. In that role she worked diligently to serve students with incredible dedication, increasing the enrollment in the program to the maximum amount allowed by the grant and providing additional opportunities for student growth and success; and

WHEREAS, Professor Stevens was provided an opportunity to return to faculty in Fall 2024 in the Engineering Science program, made possible due to her multiple degrees and vast experience. Since returning to the faculty, she has added an educator's touch to a very technical curriculum, designing courses that foster classroom engagement and providing regular support to students; and

WHEREAS, Professor Stevens has maintained her efforts in student research experiences through collaboration on a U-SURE grant, co-developed and taught non-credit technical bootcamps like Real Life Rosie's, and continues to take extra time with students during extended office hours to ensure they receive the support they need; and

### RESOLUTION OF APPRECIATION FOR PROVOST & SENIOR VICE PRESIDENT ANASTASIA L. URTZ, J.D.

WHEREAS, Anastasia Urtz began her career at Onondaga Community College in 2010 as Vice President of College-Affiliated Enterprises, and role she held until 2018. She transitioned into the role of Interim Provost and Senior Vice President for a few years until she was permanently awarded the role in 2021; and

WHEREAS, as Provost and Senior Vice President at Onondaga Community College, Anastasia led implementation of a guided pathways model of integrated student supports; fostered faculty redesign of the curriculum to reflect changing demographics and regional workforce needs, resulting in over 20 new programs; and collaborated to strengthen the high school to college pipeline, engage adult learners, expand civic engagement, and foster student success, all leading to enrollment gains at OCC; and

She was a 2017-2018 Fellow of the American Council on Education (ACE) and in 2022 was one of thirty women chosen nationwide by the ACE Women's Network for its inaugural "Moving the Needle" mentorship program; and

She has a record of public service focused on rural community development, sustainability, the well-being of children and families, education, social justice, and the arts, including her current role as Vice President of CNY Arts, a regional arts council serving six counties.
