# Call to Order

# **President's Report**

#### SUNY Updates

Trustee Sindoni introduced Dr. Warren Hilton, President, to provide his report. Dr. Hilton began with a SUNY update. He explained that SUNY is promising a \$200 million investment for a digital transformation to better support students, faculty and staff, and campuses in three areas: student and business applications development, data integration and analytics, and cybersecurity and backbone infrastructure. Their work continues with Digital Academic Support Solutions and a Digital Backpack and we expect a Non-Credit Student Information System to launch in January or February 2025.

### Enrollment Update

Dr. Hilton continued his report by introducing Sarah Gaffney, Vice President, Enrollment Management, to provide an update on enrollment. Ms. Gaffney began by showing the increase we are seeing from spring 2023 to spring 2024 in headcount. She then reviewed some new student enrollment efforts such as work with community organizations, the use of Motomatic, and the work of the admission specialists towards specific populations of students. Ms. Gaffney then reviewed marketing efforts which include radio ads, debt messaging, and the fall open house campaign. She then provided an overview of how the above-mentioned actions are helping to achieve the goals set forth in the Strategic Enrollment Master Plan.

### Student Success Update

Dr. Hilton continued his report by stating that continuing student enrollment rates are up but our retention rates are also up over 14%. He offered his congratulations to our fall athletics teams and mentioned that Cross Country finished 4<sup>th</sup> in the country at their National Championship meet; Women's Soccer made it to the national championships; and the new Wrestling team had their first match.

# **Committee Reports**

<u>Finance, Audit and Compliance Committee</u> Trustee Tryniski recapped the agenda of the Finance Committee.

Trustee Alicea recapped the agenda of the Education Committee.

# Student Government Association

Trustee Oberlender mentioned that they are hosting a number of activities this week to finish the semester. All of Student Government officers attended the SUNY Student Assembly conference in Syracuse this year and were able to meet other SGA students from colleges in New York. Programming ideas for spring are in place and the current SGA president resigned and was replaced by the Vice President. We are hoping to fill two vacancies for spring 2025.

# OCC Foundation

Trustee Sindoni introduced Executive Director of the OCC Foundation, Louis Noce, to provide an update. In late August the Foundation secured a major gift of \$1.8 million. The benefactor was not an alum, but rather a humble community member that loved the College's mission. The areas of support the benefactor requested include: Electrical Technology, Health, and Education. Each area noted will be provided scholarship funds in the amount of \$600k each. There is a chance for additional residual funding from the estate within a few months. The Foundation board of directors is looking for an ex-officio member to serve from the Board of Trustees. Any interested Trustees can reach out to Julie Hart.

### **Executive Session**
