**WHEREAS**, new programs at Onondaga Community College originate from transfer requirements, industry needs, student and community input, faculty recommendations, and/or program review; and

**WHEREAS**, review and consultation for such new programs will occur with the Provost, Assistant Provost, and Academic Deans and within Academic Departments, Curriculum Committee, Learning Outcomes Assessment Committee, and Faculty Senate as a whole with further review of such new programs conducted by the State University of New York and the New York State Education Department; and

**WHEREAS**, the Provost has discussed the new program proposal with faculty leaders and hereby requests endorsement by the Board of Trustees to conduct a cost and feasibility analysis to be completed by an independent consultant consistent with the requirements outlined in the College's Curriculum Handbook, subject to the College President making a final determination concerning whether to proceed with any new program; and

**WHEREAS**, the President has recommended deactivation and future discontinuance of the Architectural Technology A.A.S. and Interior Design A.A.S. programs due to misalignment with labor market needs and curricular barriers to student success; and

**WHEREAS**, regional labor market analysis reveals a need for computer-aided design technicians and a program in Architectural Design Technology could potentially meet this demonstrated need; and


**WHEREAS**, the Provost has recommended to the College President and the College President hereby recommends to the Board of Trustees that an Architectural Design Technology program be endorsed for a feasibility study; and

**WHEREAS**, the Board of Trustees recognizes that the program resulting from the feasibility analysis will be appropriately designed to fulfill the requirements of a credential the College is authorized to grant (e.g., Certificate, Associate of Arts, Associate of Sciences, Associate of Applied Sciences, Associate in Occupational Studies);

**NOW, THEREFORE BE IT RESOLVED**, that the Board of Trustees of Onondaga Community College hereby endorses a feasibility study for an Architectural Design Technology A.A.S. degree program consistent with the College's existing authority to develop certificates and associate degrees.

**WHEREAS**, there is a demonstrated labor market need for Licensed Practical Nurses in addition to Certified Nursing Assistants and Registered Nurses; and



**RESOLUTION TO DEACTIVATE AND DISCONTINUE ARCHITECTURAL TECHNOLOGY A.A.S. AND INTERIOR DESIGN A.A.S.**

**WHEREAS**, the Faculty Collective Bargaining Agreement outlines a process for Program Mix Administrative Review (6.18); and

**WHEREAS**, the Architectural Technology A.A.S. and Interior Design A.A.S. were selected for Program Mix Administrative Review, more commonly known as the Academic Program Revitalization Review, on November 12, 2020; and

**WHEREAS**, the College, together with the faculty, conducted an impartial analysis of programs selected for review, taking into consideration enrollment, current labor market conditions, projected regional employment opportunities, and curricular barriers to student success; and

**WHEREAS**, at the conclusion of the 2020-2021 Program Mix Administrative Review, the College President recommended, and the Board of Trustees approved, the Architectural Technology A.A.S. and Interior Design A.A.S. for further consideration of program discontinuance; and

**WHEREAS**, a Faculty Senate Ad-Hoc Committee and the Federation reviewed all Program Revitalization materials and recommended program revision of Architectural Technology A.A.S. and Interior Design A.A.S. instead of program discontinuance; and

**WHEREAS**, after careful consideration of Senate and Federation reports on discontinuance and after further consultation with the Provost, the President recommends deactivation and discontinuance of Interior Design A.A.S. and Architectural Technology A.A.S. and replacement of the Architectural Technology A.A.S. with a newly developed degree; and


**WHEREAS**, the deactivation and discontinuance of these programs requires no retrenchment of faculty and teach-out plans have been developed to ensure that students currently enrolled in these programs are able to complete their degrees; and

**WHEREAS**, following Board authorization, faculty in the Applied Engineering Technology program will conduct a feasibility study to consider development of a new Architectural Design program with the intention of better aligning the College's academic program mix with regional market demand for computer-aided drafting and design professionals;

**NOW, THEREFORE BE IT RESOLVED**, the Board of Trustees approves the deactivation and future discontinuance of the Architectural Technology A.A.S. and Interior Design A.A.S. programs effective fall 2022.
