### RESOLUTION TO ENDORSE A FEASIBILITY STUDY FOR A NEW GRAPHIC DESIGN PROGRAM

WHEREAS, new programs at Onondaga Community College originate from transfer requirements, industry needs, student and community input, faculty recommendations, and/or program review; and

WHEREAS, review and consultation for such new programs will occur with the Provost, Assistant Provost, Academic Deans, and within Academic Departments, Curriculum Committee, Learning Outcomes Assessment Committee, and Faculty Senate as a whole with further review of such new programs conducted by the State University of New York and the New York State Education Department; and

WHEREAS, the Provost has discussed the new program proposal with faculty leaders and hereby requests endorsement by the Board of Trustees to conduct a cost and feasibility analysis to be completed by an independent consultant consistent with the requirements outlined in the College's Curriculum Handbook, subject to the College President making a final determination concerning whether to proceed with any new program; and

**WHEREAS**, the College seeks to develop career pathways to serve graduates of the Syracuse City School District's proposed STEAM high school; and

WHEREAS, the proposed STEAM high school curriculum will include a concentration in media technology and design for students interested in fields such as graphic design, commercial art/advertising, and web design; and

WHEREAS, a new academic program focused on graphic design formats, product design, and digital communication will meet the demand of local employers in fields such as marketing, advertising, and graphic design; and

WHEREAS, the Board of Trustee recognizes that the program resulting from the feasibility analysis will be appropriately designed to fulfill the requirements of a credential the College is authorized to grant (e.g., Certificate, Associate of Arts, Associate of Sciences, Associate of Applied Sciences, Associate in Occupational Studies);

**NOW, THEREFORE BE IT RESOLVED,** that the Board of Trustees of Onondaga Community College hereby endorses a feasibility study for a Graphic Design program consistent with the College's existing authority to develop certificates and associate degrees.

# RESOLUTION TO APPROVE THE ONONDAGA COMMUNITY COLLEGE ASSOCIATION, INC. OPERATING BUDGET FOR THE 2022-23 FISCAL YEAR

WHEREAS, the purpose and mission of the Onondaga Community College Association, Inc. (OCCA), is to establish, manage and promote educational, cultural, athletic, social, and supportive activities and programs for Onondaga Community College students in collaboration with Onondaga Community College (the College); and

WHEREAS, the OCCA has prepared its 2022-23 operating budget using a zero-based budget approach consistent with the College's budget model, and the OCCA Board of Directors exercised due diligence in reviewing the 2022-23 operating budget; and

WHEREAS, on May 5, 2022, the OCCA Finance and Audit Committee presented to the OCCA Board of Directors and recommended Board approval of a balanced budget in the amount of \$2,918,390 which includes a per semester student activity fee of \$55.00 for full-time students and \$30.00 for part-time students per semester; the one-time new student programming fee of \$34.00 per semester; and the Recreation and Wellness Fee for full-time students at \$105.00 and for part-time students at \$65.00 per semester, and

WHEREAS, the 2022-23 operating budget provides for and allocates resources in a manner that is consistent with the OCCA and College mission and goals, as well as the mission, goals and objectives of the affiliate entities; and

WHEREAS, the OCCA Board of Directors reviewed and approved its 2022-23 operating budget at its meeting on May 5, 2022; and

WHEREAS, the OCCA Board of Directors approved a student activity fee of \$55.00 for full-time students and \$30.00 for part-time students per semester; the one-time new student programming fee of \$34.00 per semester; and the Recreation and Wellness Fee for full-time students at \$105.00 and for part-time students at \$65.00 per semester;

**NOW, THEREFORE BE IT RESOLVED,** that the Onondaga Community College Board of Trustees approves the OCCA operating budget for the 2022-23 fiscal year.

### RESOLUTION TO APPROVE THE APPOINTMENT OF CASEY CRABILL, Ed.D. PRESIDENT EMERITA OF ONONDAGA COMMUNITY COLLEGE

WHEREAS, Casey Crabill, Ed.D., has served with great distinction as President of Onondaga Community College since 2013 and will retire effective June 30, 2022 after 9 years of service to the College. A lifelong educator and native of East Greenbush near Albany, Dr. Crabill began her career teaching English; she served as a college president in California, Connecticut, and New Jersey before returning to New York to finish her career at Onondaga Community College; and

WHEREAS, Dr. Crabill was responsible for numerous initiatives on campus that reinforced her belief in a "students first" approach. One of these was the creation of the first ever Box of Books program. Done in conjunction with Barnes & Noble, this program cut the costs of textbooks in half by establishing a per credit hour scale and provided students with the opportunity to purchase laptops at reduced prices. This program is now being piloted at a number of other campuses, but it was the intuitive thinking of Dr. Crabill that brought this program to OCC; and

WHEREAS, Dr. Crabill continued her "students first" approach with the reorganization of the College's degree and certificate programs into 8 schools, each with a unique academic focus, creating a home for students with similar interests and goals. Each school has a team of faculty, advisors, and student coaches who specialize in specific areas and are dedicated to supporting student success; and

WHEREAS, Dr. Crabill came to OCC with a strong commitment to Phi Theta Kappa having once been a member herself. Her passion for the organization helped to spark a resurgence of the honor society on campus, and she worked with the OCC Foundation to develop funding opportunities that reduced the cost of membership for students. This resulted in OCC's chapter climbing the ranks to top 10 in the world each of the last 4 academic years; in 2022, OCC's chapter was ranked 3rd in the world out of 1,300 chapters; and

WHEREAS, Dr. Crabill's work to eliminate barriers across campus continued as she worked to ratify the contracts for the bargaining units through an interest-based bargaining model that was started a year prior to the expiration of the contracts — contracts that were settled ahead of time and with a number of significant accomplishments due to the cooperation of both sides. Also completed during this time was the creation of a faculty senate model which provided much needed transparency amongst the faculty and the campus community; and

WHEREAS, Dr. Crabill's work continued with a successful Middle States reaccreditation in 2018 and her work on the College's Strategic Plan "Lazer Focus" in 2016; these elements, along with a strong assessment approach, were crucial to the continued efforts to increase enrollment. OCC continued to respond to industry demands by creating new degree and certificate programs including Paramedic, Health Sciences, Health Studies, Electromechanical: Drone Technology, Geospatial Science & Technology; Sound Recording, and Creative Writing; and

WHEREAS, Onondaga Community College has long been known for its beautiful facilities, but Dr. Crabill took that one step further with capital projects such as the complete renovation of the Coulter Library building, reconstruction of the West Quad, and the certification of Academic II and the SRC Arena as LEED Gold buildings. She was also a fiscally responsible leader, demonstrating her ability to reduce expenses efficiently in the face of reduced support. When she started at OCC, the annual operating budget was \$78 million; during the 2021-22 academic year, the budget was \$64.5 million; and

WHEREAS, Dr. Crabill has been instrumental throughout her tenure in finding critical partnerships that lead to the success of the students of OCC. She embedded herself in the Central New York Community and developed strong relationships with local leaders which has led to the creation and continuation of numerous scholarships, student awards, emergency funding and faculty support. Dr. Crabill initiated the OCC Advantage program by partnering with 5 local area high schools to deliver this college and career

readiness programming. By sharing her vision within the community, the program has raised significant financial resources and will continue to grow and support local students. Dr Crabill also worked with the Slutzker Family Foundation to create the Lillian Slutzker Honors College. The Lillian Slutzker Honors College provides high-achieving students with an intellectually stimulating and challenging academic experience while removing barriers associated with the costs of these experiences. Her continued dedication, passion and understanding of student needs led to the capstone gift of her philanthropic efforts. She was able to share in the vision with Eric Allyn to honor Meg O'Connell with a one-million-dollar contribution to the Meg O'Connell Center for Social Justice and Community Impact. The center will house the Meg O'Connell Scholars & Mentor program which will financially support students and provides access to opportunities in Central New York to better the community; and

WHEREAS, Dr. Crabill was a strong supporter of Athletics during one of the most successful times in OCC athletics history. These accolades include 6 NJCAA Team National Championships; 8 NJCAA Individual National Championships; 21 Region III Championships; and 32 Mid-State Athletic Conference Championships. A servant leader, Dr. Crabill's support of the Central New York community was evident through her work on boards such as the Central New York Community Foundation, CenterState CEO, Clear Path for Veterans, and the Manufacturer's Association of Central New York; and

WHEREAS, one of the biggest challenges to face any college president in 2020 was the COVID-19 pandemic. From the day the campus closed to its reopening a few months later, Dr. Crabill was a proactive leader, providing much needed support to a campus inherently effected by the rages of the virus. Employees rallied to provide safe spaces, technology, and support for students to return in fall of 2020. Classes remained primarily in person while virtual options were expanded, all the while maintaining a student-first approach during one of the most critical times in the College's history; and

WHEREAS, because of her steadfast leadership and student focused approach, Dr. Crabill is leaving Onondaga Community College a better place than when she arrived. The College community will be forever grateful to her and we wish her well in her retirement;

**NOW, THEREFORE BE IT RESOLVED**, in recognition of her exemplary service and her transformational legacy at Onondaga Community College, Casey Crabill, Ed.D., is now and shall forever be entitled to the position of President Emerita of Onondaga Community College, a title meaning "earned through service", with all the benefits, privileges and rights accruing thereto, which shall include, but not be limited to, the following:

- Permanent designation as President Emerita to be indicated perpetually across campus, where applicable;
- Appointment as Distinguished Full Professor should she ever desire to contribute to Onondaga Community College as an academic;
- A standing invitation to College events;
- Regular updates and communications from Onondaga Community College; and
- Other privileges as deemed appropriate by the Onondaga Community College Board of Trustees.

NOW THEREFORE BE IT RESOLVED, that after her retirement, Dr. Kathleen Crabill is hereby entitled to defense and indemnification in any civil proceeding, including but not limited to a government agency administrative proceeding or one that is brought in state or federal court, arising out of any act or omission which occurred while Dr. Crabill was acting within the scope of her employment or duties as President or which is brought to enforce a provision of Sections 1981 or 1983 of Title 42 of the United States Code (pertaining to an alleged violation of federal civil rights) under circumstances where the act of omission underlying the action occurred or is alleged in the complaint to have occurred while Dr. Crabill was acting within the scope of her employment or duties as President of the College; and

BE IT FURTHER RESOLVED, that Mr. David Wall is hereby entitled to defense and indemnification in any civil proceeding, including but not limited to a government agency administrative proceeding or one that is brought in state or federal court, arising out of any act or omission which occurred while Mr. Wall was acting within the scope of his employment or duties as the Director of Campus Safety and Security or which is brought to enforce a provision of Sections 1981 or 1983 of Title 42 of the United States Code (pertaining to an alleged violation of federal civil rights) under circumstances where the act of omission underlying the action occurred or is alleged in the complaint to have occurred while Mr. Wall was acting within the scope of his employment or duties as Director of Campus Safety and Security.
