# RESOLUTION TO APPROVE THE ONONDAGA COMMUNITY COLLEGE ASSOCIATION, INC. OPERATING BUDGET FOR THE 2024-25 FISCAL YEAR

WHEREAS, the purpose and mission of the Onondaga Community College Association, Inc. (OCCA), is to establish, manage and promote educational, cultural, athletic, social, and supportive activities and programs for Onondaga Community College students in collaboration with Onondaga Community College (the College); and

WHEREAS, the OCCA has prepared its 2024-25 operating budget using a zero-based budget approach consistent with the College's budget model, and the OCCA Board of Directors exercised due diligence in reviewing the 2024-25 operating budget; and

WHEREAS, on May 8, 2024, the OCCA Finance and Audit Committee presented to the OCCA Board of Directors and recommended Board approval of a balanced budget in the amount of \$3,405,674 which includes a per semester student activity fee of \$65.00 for full-time students and \$40.00 for part-time students per semester; the one-time new student programming fee of \$34.00 per semester; and the Recreation and Wellness Fee for full-time students at \$125.00 and for part-time students at \$85.00 per semester, and

WHEREAS, the 2024-25 operating budget provides for and allocates resources in a manner that is consistent with the OCCA and College mission and goals, as well as the mission, goals and objectives of the affiliate entities; and

WHEREAS, the OCCA Board of Directors reviewed and approved its 2024-25 operating budget at its meeting on May 8, 2024; and

WHEREAS, the OCCA Board of Directors approved a student activity fee of \$65.00 for full-time students and \$40.00 for part-time students per semester; the one-time new student programming fee of \$34.00 per semester; and the Recreation and Wellness Fee for full-time students at \$125.00 and for part-time students at \$85.00 per semester;

**NOW, THEREFORE BE IT RESOLVED,** that the Onondaga Community College Board of Trustees approves the OCCA operating budget for the 2024-25 fiscal year.

WHEREAS, in 2007, he enrolled in Onondaga Community College's Business Administration degree program. He completed his degree two years later and earned a bachelor's degree from Columbia College. While training and helping more than a thousand refugees find work, he received numerous community-based awards, including a Certificate of Recognition from the Syracuse City School District for consistently exhibiting grace, empathy, and professionalism while working with clients, a Certificate of Recognition from SUNY Upstate Medical University for outstanding performance and lasting contributions to the Nursing Grant Rounds, and was inducted into the YWCA Academy of Diversity Achievers; and

WHEREAS, Mr. Mondom continues to give back to the community as a member of several advisory boards including the Healthcare Advancement Resources Center; the CNY Blessing Box Food Pantry; the New Americans Forum; and most recently the CNY Regional Economic Development Advisory Group to help organize advanced manufacturing training in Syracuse in conjunction with the arrival of Micron. He's also a member of the World Refugee Day Celebration Committee and is known as the "flag man" for the creative hat he wears which displays flags from around the world; and

**WHEREAS**, for his outstanding service to the College, the Syracuse community and beyond, President Warren Hilton, Ed.D. recommends that the Board of Trustees approve Jasenko Mondom as a recipient of the 2024 John H. Mulroy Founder's Award;

During the COVID pandemic, CineMedic CNY mastered the skills associated with being a clinical laboratory that specializes in logistics in austere environments. They created daily COVID testing protocols on movie sets which became the industry standard; and

WHEREAS, in 2021, Ms. Drake-Bianchi learned Onondaga Community College had created a Paramedic degree and certificate program in conjunction with SUNY Upstate Medical University. She responded to the critical need in the community for paramedics by gifting the OCC Foundation \$80,000 for the creation of a two-tiered student scholarship program; and

WHEREAS, recently, Ms. Drake-Bianchi reacted to the strain that has been placed on emergency rooms and doctor offices overwhelmed by people needed medical care by opening Drakos Urgent Care, a pediatric urgent care center in Clay. The response was overwhelming and led to the creation of a second facility in Cicero which caters to both adults and children. Each facility is open until midnight, seven days a week, filling a critical need in the Central New York Community; and

WHEREAS, Heather Drake-Bianchi has dedicated her life to the wellbeing of others, and in the process, has contributed greatly to the success of one of Onondaga Community College's programs which helps to fill a critical workforce need, and is providing a tremendous service to the community with the creation of two new urgent care offices; and

**WHEREAS**, for her outstanding service to the College, the Syracuse community and beyond, President Warren Hilton, Ed.D., recommends that the Board of Trustees approve Heather Drake-Bianchi as a recipient of the 2024 John H. Mulroy Founder's Award;

WHEREAS, James Carey began working at OCC as an Assistant Professor in 1981 until his retirement 42 years later. One of OCC's longest serving faculty, Mr. Carey's passion for the classroom never waned; and

WHEREAS, Mr. Carey's work often took him into the community, including the development of the Greater Syracuse Small Business Development Center, putting Syracuse on the map as the only city in the country with a SBDC regional office. Community Education was another of his passions and he worked on numerous training grants where he delivered the training or outsourced it, along with grants for many manufacturing companies in Central New York, including New Venture Gear and Bristol Myers Squibb. Mr. Carey was active in local non-profits such as Meals on Wheels and Enable and was a frequent presenter at local colleges on partnerships and online instruction; and

WHEREAS, Mr. Carey served on numerous committees at OCC, including the Teaching and Learning Project (now called CTLI), numerous Middle States Teams, and the creation of the Institutional Review Board. He also participated on the General Education Committee and worked directly with SUNY and the Gen Ed mandates that materialized sometime later. In 1991, he rewrote the College's original mission statement which dated back to 1962 and convened a SUNY-wide committee of Business faculty from the 64 SUNY colleges to review common requirements for business degrees. Mr. Carey was a participant in numerous search committees and an award recipient many times over, include the Ralph R. Whitney award in 2016; a Chancellor's award for Excellence in Teaching in 2017; a Trustee award recognition in 2001; and the Paragon award in 2002; and
